

## General Terms and Conditions

### Definition

Verein zur Förderung der Fort- und Weiterbildung in der Gastroenterologie, Hepatologie und Endokrinologie e.V. (hereafter referred to as GHE e.V.) is the Professional Conference Organizer of the Joint International Meeting on Viral Infections of the Liver and the Heart, which takes place in Berlin, Germany, from 17<sup>th</sup> to 18<sup>th</sup> January 2025. These General Terms and Conditions are valid for each registered attendee of this Symposium. Any person registered (delegate, invited speaker, exhibitor, sponsor etc.) is considered an attendee.

### Registration and Payment

The registration and payment deadlines are as follows:

Standard registration deadline for in-person participation: 07<sup>th</sup> January, 2024 24:00:00 (CEST)  
Later registrations may be allowed at the organizer's discretion.

Standard registration deadline for virtual attendance: 17<sup>th</sup> January, 2024

Registration can only be made online by completing the registration form at <https://eveeno.com/berlin2025>

Everyone who wants to attend must register. Until the standard registration deadline, the registration to the congress is solely possible via the online registration form. The participant will receive an official confirmation of registration/invoice from [eveeno](https://eveeno.com) via email. All registration fees must be paid in due time according to the due date stated on the invoice. Otherwise, the Congress Organization reserves the right to deny access to the meeting.

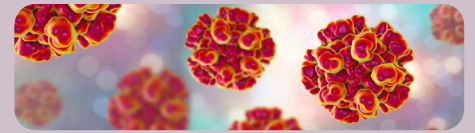
Payments are only accepted in EUR and can be made by credit card or by bank transfer. Bank transfer is only for Single Euro Payments Area (SEPA). Cheques will not be accepted. All registration fees must be fully paid prior to the congress. Exceptions can only be made, if a written request has been officially confirmed by GHE e.V.. In this case, payment may be made on-site at the registration desk in cash. Only after full payment has been received, the registration will be considered valid.

### Cancellation Policy

All registration changes and cancellations must be communicated to GHE e.V. in written form by email to [kongress-ghe@mh-hannover.de](mailto:kongress-ghe@mh-hannover.de). In case of cancellation of the registration received before 15<sup>th</sup> December, no cancellation fee will apply. For any cancellations received after 15<sup>th</sup> December 2024, a cancellation fee of 50% of the registration fee applies. No refund will be given for any cancellations made after 31<sup>st</sup> December 2024, and the claim for the full payment of all registration fees remains. No refund will be given for unattended events, in case of illness or early termination of attendance.

### Film, Photo and Video Recordings

GHE e.V. and the co-organizing institutions are collaborating closely to create a comprehensive overview of the congress programme, interactions and events that may be of promotional interest. Accordingly, please be informed that you may be filmed or photographed at any time (e. g. in the session rooms, or in the poster and exhibition area) and any presentation you deliver may be recorded. With the registration to the congress, attendees confirm and agree to the publication of the above-mentioned photo/video material related the Joint International Meeting on Viral Infections of the Liver and the Heart website or printed matters.



### **Name badge**

On arrival at the congress venue, every attendee needs to proceed to the registration desk first in order to pick up the name badge and the congress material.
